## About this property

This wonderful bay fronted extended family residence occupies a corner plot overlooking Syddal Green. The property itself reveals in excess of 1400 sq/ft of living accommodation and features a delightful entrance hall which leads into a bay fronted living room. There is a large extended second reception room in the form of a sitting room which incorporates double doors leading onto the rear garden. A study and downstairs WC add to the ground floor accommodation whilst a bright and spacious kitchen dining room also enjoys access to the rear garden with views across Syddal Green. To the first floor there are three double bedrooms and a modern family bathroom. The property enjoys a well maintained garden, offering both privacy and space. There is a courtyard style patio area immediately outside the kitchen area and this promotes a comfortable outdoor seating area. The remainder of the garden is mainly laid to lawn but includes a range of established borders. A single brick built detached garage and a useful storage room create additional space for all the garden essentials. As the property sits on a corner plot there is a spacious block paved driveway to one side with gardens wrapping around the front & side of the perimeter with mature hedging adding some privacy to the plot.

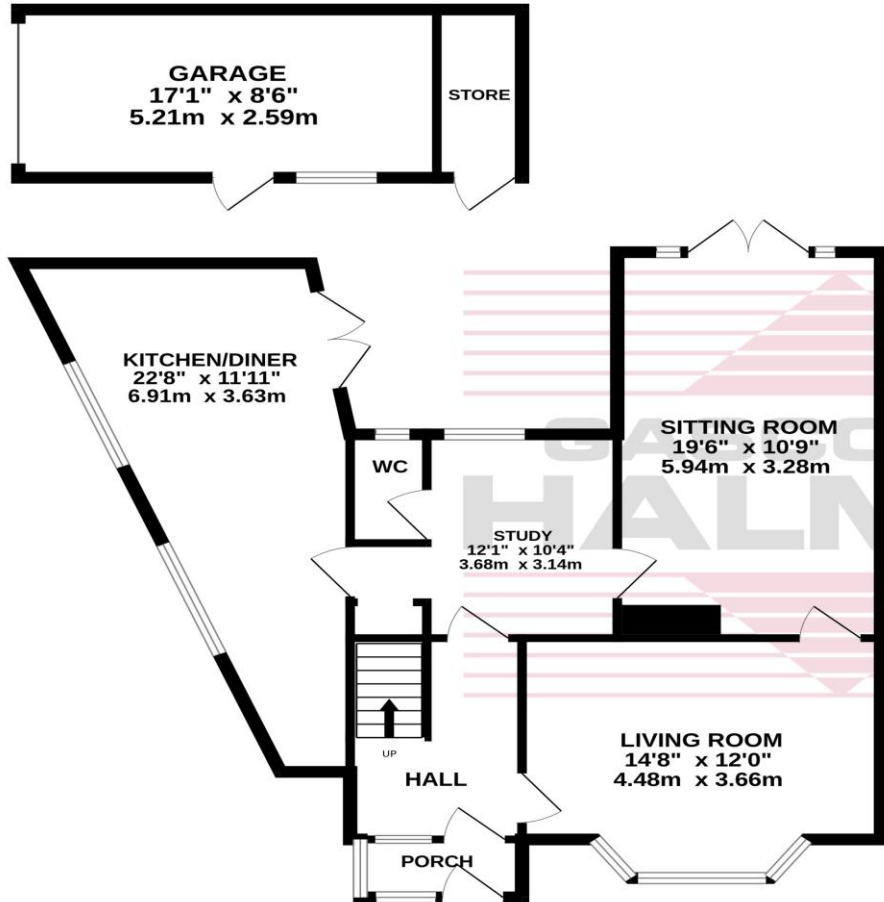

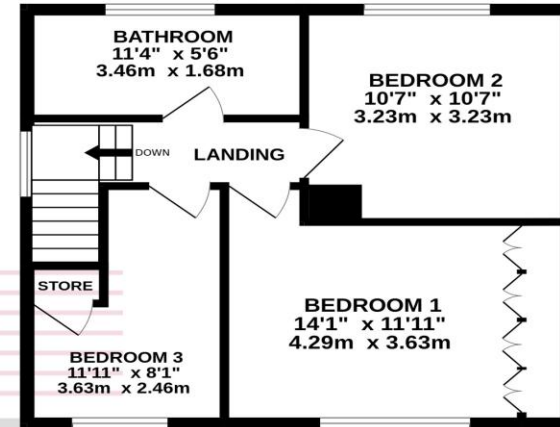
