Location

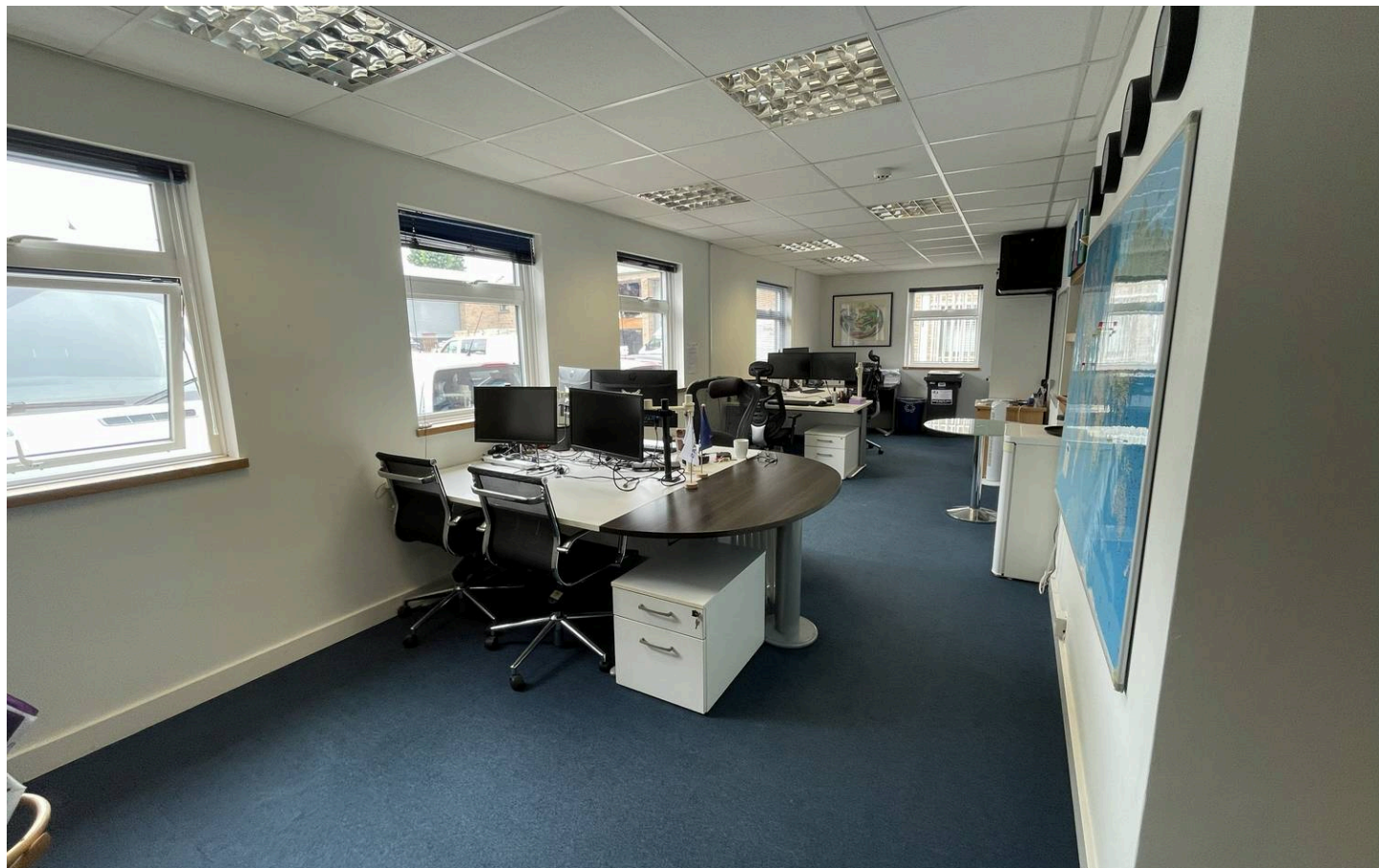
